PREAMBLE

After the back to back deaths of two kids with disabilities in two different organisations for the disabled children, PARIVAAR BENGAL and DAF West Bengal got together and convened a meeting of the Disability Organisations working in West Bengal for a collaborative meeting on 26th February 2019 at Manovikas Kendra.

At the meeting it was decided to develop a format for monitoring safety within the organisations those work with disabled children/people, which will also act as a guideline for directing/sensitising them regarding safety measures to be put in place. A smaller committee was set up at the meeting to work on developing this format.

The document developed by this committee was shared and discussed in a broad based meeting held on **20th September 2019 at Manovikas Kendra**. Almost 48 NGOs and institutions along with individuals working in the sector assembled on 20th September 2019 and after threadbare discussion put forward their valued points. We incorporated many such suggestions and the document was ultimately finalised.

The document, we hope, will be a guideline for the organisations and institutions working with and for persons with disabilities in developing the policies and practices those are user centric, keeping in mind the dignity of the individual and respect for difference. The format suggests the basic frame work and each organisation can adopt it for their own - depending on its size, disabilities dealt with and contextual situation. The frame work is comprehensive and inclusive of all disabilities, to the extent possible.

These guidelines assume that all institutions and organisations working with and for persons with disabilities will seek to provide a healthy, safe and conducive environment for living, learning and working. Safety should be a continuous planned process, an integral part of the management of any organisation or institution. A responsible attitude to safety will act as a motivator internally amongst staff, parents and users who will be reassured that their well-being is of paramount interest. Compliance requires a sustained, systematic and organised approach, revisiting risk assessments, checking, acting on new information. Every institution/ organisation needs to work through a two pronged approach – developing relevant policy frameworks and applying the same in their everyday practices in order to ensure justice for all people concerned, specifically users of services.

We hope this policy will act as a guide for all organisations working with disabled people and can also serve a monitoring tool for state agencies.
