There are five National Awards.

- 1. National Award for Excellent Therapist (Occupational/Physiotherapy/Speech Therapist)
- 2. National Award for Excellent Special Educator (Intellectual Disability/Hearing/Visual/CP/Autism)
- 3. National Award for Excellent Social Worker (working for the cause of Divyangjan)
- 4. National Award for Excellent Institution (Providing Holistic services to the Persons with Disabilities)
- 5. National Award for Excellent Govt. Official (Exemplary support in implementing Govt. Policies/ schemes and programmes for Divyangjan)

## Each award carries a Citation, a Trophy and a Cash Prize of Rs. 11,000.

The Council of Advisors and Selection Committees for the awards play a pivotal role in maintaining the integrity of the awards and enhancing the objectives of the Organization. ### Rules

- 1. The awards are open for Indian citizen only.
- 2. In each category one award will be given.
- 3. For Individual category the person must be serving in disability sector for minimum 5 years.
- 4. In Organization category minimum 5 years working in disability sector is must.
- 5. The details along with the supporting should be sent online in PDF format only. The file can contain maximum 10 pages (A4) including photographs/ media reports/ other supporting.
- 6. The jury decision will be final and no correspondence of any type will be entertained on decision.
- 7. One person can send only one entry.
  - 8. The award function will be held at Nagda on 10<sup>th</sup> July (Foundation Day of SNEH) for which the awardees' will have to bear the travel expenditures. The lodging and boarding along with local logistics will be arrangement by SNEH.

## • For Best Individual (Therapist/Special Educator/Social Worker):-

- (i) Dr. Naina Memorial SNEHEBILITY National Awards shall be given to individuals (one each to professional) working for the cause and empowerment of the persons with disabilities.
- (ii) Awards shall be presented to the individual who has rendered best work in the cause of the disability. Eminence of individual shall be determined on the following basis:
  - a. The organization in which he/she works considers him/her as outstanding.
  - b. He/she has been responsible for initiating new program or services in the last 5 years resulting in benefiting the people with disabilities particularly in rural areas.
  - c. Paid officers of the Institution shall not be eligible for selection. However, paid workers/officers of the NGOs working for the cause of the disabled could be eligible.
  - d. His/her contribution should be outstanding in the areas of disabled welfare/rehabilitation/ education/training etc.
  - e. His/her contribution in developing rehabilitation model for Community Based Rehabilitation and replicating the same in the inaccessible rural areas.
  - f. Outstanding person championing the welfare and overall development of the disabled and sensitizing the community regarding rights and equal opportunities for the disabled.
  - g. The quality of the work performed by the individual in the cause of the disabled and its significance for the cause shall also be given due weight- age.
  - h. He/she has outstanding professional achievements to his/her credit.
- (iii) The applications should be send in the prescribed format attached Annexure-A
