Constitution of Committee to Review National Policy for Persons

with Disabilities, 2006

The undersigned is directed to say that the National Policy for Persons with Disabilities was adopted in 2006. Subsequently, India became a party to United Nations Convention on Rights of Persons with Disabilities (UNCRPD) which was ratified on 01.10.2007. The Central Government has also enacted the Rights of Persons with Disabilities Act, 2016 which came into force from 19.04.2017. The Act is in line with the provision of the above UN Convention.

2. Given the above developments, the National Policy for Persons with Disabilities, 2006 needs to be reviewed to bring it in line with the new law and in harmony with the provisions of UNCRPD. With a view to review the existing National Policy, it has now been decided with the approval of the competent authority to constitute a Committee with the following composition and terms of reference:-

(c) The non-official members coming from outside Delhi will be entitled for TA/DA as applicable to Class I officer of the Central Government. In case of other members, it will be borne by their respective organizations.
